Commissioner Mejos reported she meet with Supervisor Rabbitt, and was informed that the County granted \$500,000 for designated non-profits working to provide pro-bono legal services, social services, and mental health services to meet the needs of the undocumented population in the face of immigration enforcement.
- c. Commissioner Jones-Carter shared that the Junior Commission had their Orientation on Saturday, August 10th and about 25 students showed up.
- d. Commissioners Gordon and Beaty met with Tracy Lyons- BOS Chair Hopkins' Chief of Staff to discuss how the Commission can better align its agenda with the Board of Supervisors' legislative priorities. She suggested meeting with the new Chair of the BOS yearly, communicating with appointed Supervisors, reintroducing past reports when relevant agenda items arise, submitting CSW reports as public comment, and reviewing the Municipal Advisory Council (MAC) agendas to identify other topics of current interest, e.g., how Accessory Dwelling Units (ADUs) could help reduce the housing crisis in the County, farmworker housing, and women's economic security.
- e. The County of Sonoma Invited CSW to attend the BOS meeting on October 7, 2025 at 1:30pm to accept a gold resolution in honor of Domestic Violence Awareness Month.
